

# THE ROAD TO HANA SWEEPSTAKES

## OFFICIAL RULES FOR CURRENT OWNERS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. **ELIGIBILITY:** The Road to Hana Owner Sweepstakes ("Sweepstakes") is open only to those who enter via our social channels – official Polaris Slingshot Instagram, Facebook, and Twitter pages, online at the official Polaris Slingshot website, take a dealer demo, and participating in a Polaris Adventure as detailed in "How to Enter" below. Employees of Polaris Industries Inc. ("Sponsor") and its subsidiaries and affiliates, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Sponsor reserves the right to verify eligibility qualifications of any winner.

**TIMING:** The Sweepstakes will run from June 21, 2019 to September 22, 2019. (the "Sweepstakes Period"). The Sweepstakes Period is subject to change at Sponsor's discretion if for any unforeseen reason the Promotion cannot be conducted as planned.

The first option is to do a dealer demo ride an authorized Slingshot dealership and filling out this [online form](#). Dealers will log each person who comes in for a demo ride. The second option is posting a photo on your Instagram, Facebook, or Twitter using the hashtag #SlingshotSummerFun. The third option is participating in a Polaris Adventure. Limit one entry per person. Participation in this Sweepstakes constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Sweepstakes.
