

THE ROAD TO HANA SWEEPSTAKES

OFFICIAL RULES FOR PROSPECTIVE OWNERS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. ELIGIBILITY: The Road to Hana Customer Sweepstakes ("Sweepstakes") is open only to those who enter via our social channels – official Slingshot Instagram, Facebook, and Twitter pages, online at the official Polaris Slingshot website, and by taking a dealer demo ride at an authorized Slingshot dealership during the Sweepstakes Period. Employees of Polaris Industries Inc. ("Sponsor") and its subsidiaries and affiliates, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Sponsor reserves the right to verify eligibility qualifications of any winner.

TIMING: The Sweepstakes will run from June 21, 2019 to September 22, 2019 (the "Sweepstakes Period"). The Sweepstakes Period is subject to change at Sponsor's discretion if for any unforeseen reason the Promotion cannot be conducted as planned.

Dealers will log each person who comes in for a demo ride. During the Sweepstakes Period, entrants can also enter by posting on a photo on Instagram, Facebook, or Twitter using the hashtag #SlingshotSummerFun. Limit one entry per person. Participation in this Sweepstakes constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Sweepstakes.

IMPROPER CONDUCT: Sponsor, in its sole discretion, may disqualify any entrant from participation in this Promotion if entrant engages in any conduct Sponsor deems to be improper unfair, acting in an unsportsmanlike or disruptive manner, or acting with intent to annoy, abuse, threaten or harass any other person or otherwise adverse to the operation of the Sweepstakes.
